*Our Family understands that our relationship with the St. Christopher School is contractual and contingent on our cooperation with the philosophy, policies and procedures detailed in the current Family Handbook. If my family does not complete the school year due to unforeseen circumstances, I accept the school's fair judgment of reimbursement/suspension of payment. By requesting that my child/ren attend St. Christopher School I willingly take on a commitment to the Tuition Plan and Option I have selected as applicable and feasible for my family and I understand that I am obligated to meet this payment schedule. We also understand that this Agreement is for the 2020-2021 academic year only, and that continued attendance at St. Christopher School will be determined according to stated policies and procedures. Finally, we understand that we are expected to actively participate at St. Christopher Parish by our weekly Mass attendance. We further understand that the tuition rates collectively represent only 52.4% of the cost to educate our child/(ren) with a significant portion subsidized by St. Christopher Church through the Sunday offertory.*
